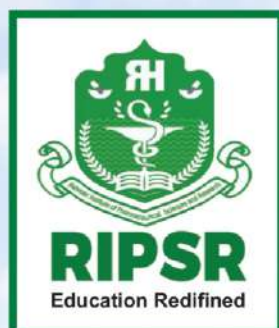

# MOULVIE ABDUL HEI MEMORIAL TRUST

**A man who truly understood the value of knowledge**



*Moulvie Abdul Hei*

Born in 1932 in Keirao Makting, a small village now part of Imphal East District, Manipur, Moulvie Abdul Hei Saheb was destined to lead a life marked by simplicity, faith, and the pursuit of knowledge. Coming from a humble background, with poor and illiterate parents, he had no one to guide his path—but his inner determination set the course for a life of purpose. From a very young age, he displayed a deep yearning for knowledge and an unwavering desire to seek truth and share it with others. This pursuit took him to a madrasa in Uttar Pradesh, where he began his Islamic theological studies. Breaking with tradition, he also pursued formal education alongside his religious studies—an uncommon path at the time. During his academic journey, he became a devoted follower of Moulana Ahmed Ali, actively supporting the freedom movement. In 1965, he completed both Pravodha and Rashtrabhasha Ratna from Bombay Hindi Vidyapeeth, further broadening his intellectual foundation.

After briefly serving as an Imam at a village mosque near a tea garden in Golaghat, Assam, he returned to Manipur in 1959 to care for his aging father. While in Assam, he married Kheirun Nisha, the daughter of a doctor at the tea garden hospital. His integrity and graceful demeanor impressed many, and with their support, he secured a government position as an Assistant Teacher at Irilbung M.E. School in 1960.

It was here that he truly left his mark—as a mentor, educator, and role model. His dedication to his students, coupled with his gentle and engaging teaching style, earned him the affectionate title “Oja Moulvie”—a name that still carries emotional resonance in the community. After years of committed service, he retired in 1988 as the Headmaster of Urup Keirao LP Madrasa.

Beyond his professional life, Moulvie Saheb embodied values that inspired everyone who knew him. His humility, patience, humor, deep spiritual wisdom, and open-mindedness made him a man admired by all. Those who spent time with him often recall his calm demeanor in every circumstance—a reflection of his profound faith in the Divine will. He was never provoked, never angered, always ready to embrace others with warmth and wisdom.

After every prayer, in every moment of reflection, he would recite “Rabbi zidni ilma”—“**O Lord, increase me in knowledge**”—a beautiful prayer that defined his life’s purpose.

Moulvie Saheb passed away on March 10, 2000, leaving behind a legacy of inspiration and learning. To honor his life and vision, the Moulvie Abdul Hei Memorial Trust was established—a tribute as enduring as the values he lived by. The Trust is devoted to nurturing academic excellence through institutions that carry forward his passion for knowledge and service to humanity.

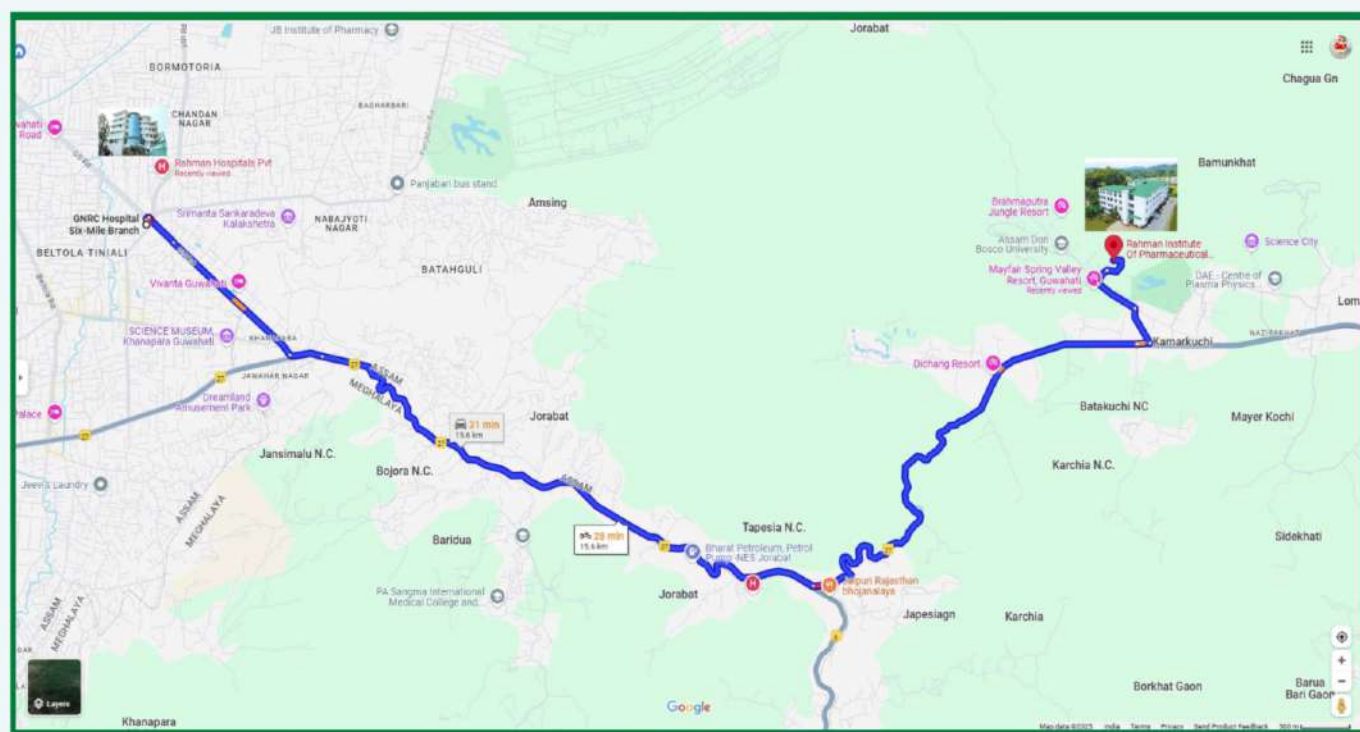

# Campus Location



The Rahman Institute of Pharmaceutical Sciences and Research (RIPSR) is located in a serene and pollution-free environment, spread across 7 acres of land in Tepesia, Kamarkuchi, Sonapur, Kamrup (M), Assam – 782402. This tranquil setting provides the perfect backdrop for academic pursuits.

The institute is conveniently situated just 400 meters from National Highway 37, directly opposite the Mayfair Resort, and in close proximity to two renowned educational institutions: Lakshmibai National Institute of Physical Education and Assam Don Bosco University.

Kamarkuchi, a village panchayat in Kamrup Metro district, is approximately 18 kilometers away from Dispur, the state capital of Assam, making it easily accessible for students and faculty alike.

# INFRASTRUCTURE

## CLASSROOMS

Our institute offers spacious, well-ventilated classrooms designed to provide an optimal learning environment. In adherence to PCI and AICTE norms, each classroom is equipped with modern amenities including whiteboards, smartboards, overhead projectors, and PA systems, ensuring a student-friendly and technologically advanced setting for education.





## LABORATORIES

The institute has 13 laboratories as per the norms stated by the Pharmacy Council of India (PCI) and the All India Council for Technical Education (AICTE). These laboratories are equipped with all major and minor instruments specified by the regulatory bodies for conducting various experiments aligned with the course curriculum. The laboratories are primarily categorized into four departments based on their specialization and utilization:

### *Department of Pharmaceutics*

The Department of Pharmaceutics is equipped with state-of-the-art laboratories and modern facilities, making it one of the most sophisticated labs. These laboratories focus on the practical aspects of manufacturing, formulation, and evaluation of various pharmaceutical dosage forms. The department includes specialized laboratories that cover areas such as pharmaceutics, physical pharmaceutics, pharmaceutical microbiology, pharmaceutical engineering, pharmaceutical technology, industrial pharmacy, and biopharmaceutics for both B.Pharm and D.Pharm courses.





## Department of Pharmaceutical Chemistry

The Department of Pharmaceutical Chemistry primarily deals with drug design and the synthesis of biologically active compounds. Its main objective is to discover new chemical entities or optimize existing drugs, thus expanding the portfolio of chemical medicines. The department is equipped with various sophisticated instruments for practicals in the B.Pharm and D.Pharm curriculum and also supports research activities in drug discovery and molecular optimization.





## Department of Pharmacology

Pharmacology is the branch of pharmacy concerned with the study, uses, effects, and mechanisms of drug action. The department focuses on both pharmacokinetics and pharmacodynamics. The laboratory is outfitted with high-end software and a range of advanced instruments such as the Rotarod apparatus, electroconvulsimeter, analgesiometer, actophotometer, student organ bath, pole climbing apparatus, and histamine chamber for studying drug effects in various models.





## Department of Pharmacognosy

The Department of Pharmacognosy features laboratories established in accordance with PCI and AICTE norms. These labs focus on crude drugs derived from natural sources including plants, animals, minerals, and microorganisms. The labs are fully equipped for the extraction and evaluation of natural products and include instruments such as a trinocular microscope, binocular microscope, moisture balance, projection microscope, polarized microscope, compound microscope, muffle furnace, distillation unit, Soxhlet apparatus, and Clevenger apparatus.





## Department of Pharmacy Practice

The Department of Pharmacy Practice is designed to provide students with hands-on training and practical experience essential for their future careers in pharmacy. The lab features state-of-the-art facilities that support a range of lab-based activities, allowing students to develop critical skills in a simulated environment. Students engage in innovative training that emphasizes integrative approaches to pharmacy practice. The curriculum focuses on real-world applications, enabling learners to practice skills such as medication dispensing, patient counseling, and pharmaceutical care. This experiential learning environment is essential for preparing students to meet the demands of the healthcare industry. Overall, the Pharmacy Practice Lab plays a vital role in shaping competent pharmacy professionals ready to contribute to patient care and the broader healthcare system.



## CENTRAL INSTRUMENTATION FACILITY AND MACHINE ROOM

The Central Instrumentation Facility at RIPSAR is equipped with essential instruments to support the course curriculum. Instruments such as the UV-VIS spectrophotometer, flame photometer, tablet disintegration and dissolution apparatuses, colorimeter, fluorimeter, polarimeter, and refractometer help students gain both foundational and applied knowledge in pharmaceutical sciences.

A dedicated Machine Room simulates an industrial setting to familiarize students with the processes of drug formulation and packaging. It includes equipment like ampoule sealing machines, tablet punching and coating machines, hardness testers, friability testers, capsule filling machines, and ointment filling machines.





## LIBRARY AND READING ROOM

The institution has a dedicated library for students and faculty, covering 1651.36 sq. ft., including a 440 sq. ft. reading area. Known as the “Central Library,” it is located on the first floor of the college building in a clean, quiet environment.

The library is furnished with wooden reading tables, proper lighting, comfortable chairs, and ceiling fans. It has a separate reading area for staff and postgraduate students with a seating capacity of around 60. Computers with internet access are available for academic use.

Library staff provide full assistance to users. The collection includes books, journals, newspapers, and magazines, classified by subject using the DDC 21st edition. Facilities include 10 computers, a photocopy machine, and a CCTV camera.



## COMPUTER LABORATORY

The institute has a computer lab with high-speed internet (32 Mbps). The lab includes 20 computers in a 1:8 student-to-system ratio, all equipped with the latest configuration and licensed software. It also houses five high-quality color printers and scanners. The entire campus is Wi-Fi enabled with several hotspot areas. All systems have UPS backup and generator support for uninterrupted service.



## HERBAL GARDEN

The Herbal Garden at RIPSr features a diverse collection of medicinal and aromatic plants. It is designed to provide students and visitors with the opportunity to explore the various uses of herbs in both culinary and medicinal contexts.

## MUSEUM

The museum at RIPSr showcases the milestones in the development of pharmacy as a profession, illustrating the evolution of pharmaceutical science.

## LANGUAGE LAB

The Language Lab has been established to help students improve their language and communication skills, aiming to build their confidence for interviews and competitive exams. The lab is equipped with computers, language learning software, and audio exercises to support grammar, vocabulary, and proper pronunciation development.

## AUDITORIUM

The institute houses a 350-seat auditorium with a stage and green room. It is well-equipped with a projector screen and a PA system for hosting academic and cultural events.

## FIRE SAFETY ARRANGEMENTS

Adequate fire safety measures are in place to ensure the protection of students, faculty, and staff.

## POWER BACKUP FACILITIES

The institute is equipped with power backup systems to maintain uninterrupted academic activities.

## CCTV

The entire campus is under 24/7 CCTV surveillance, ensuring the safety and security of students and staff.

## ELIGIBILITY CRITERIA FOR ADMISSION

**Admission to all pharmacy programmes—whether in government or private institutions—is conducted based on the Common Entrance Examination (CEE) administered by the Srimanta Sankaradeva University of Health Sciences (SSUHS).**

*Securing the prescribed cut-off marks in the CEE is mandatory for consideration of admission.*

### Diploma in Pharmacy (D.Pharm)

- The candidate must have passed the **10+2 examination** with **Physics and Chemistry** as compulsory subjects, along with any one of the following: **Mathematics / Biology / Computer Science**.
- The candidate must have secured **individual pass marks** in all three subjects (including both theory and practical, wherever applicable) under regular class mode – **Without any grace marks**.
- A minimum of **45% aggregate marks** in the aforementioned three subjects is required (with **40%** for candidates belonging to **reserved categories**).
- The candidate must have passed **English** with a minimum of **30% marks** in the 10+2 examination.
- The candidate must have completed **17 years of age** on or before **31st December** of the year of admission.
- The qualifying examination must be conducted by a Board **recognized by the Central or respective State Government**.


### Bachelor of Pharmacy (B.Pharm)

- The candidate must have passed the **10+2 examination** with **Physics and Chemistry** as compulsory subjects, along with any one of the following: **Mathematics / Biology / Computer Science**.
- The candidate must have secured **individual pass marks** in all three subjects (including both theory and practical, wherever applicable) under regular class mode – **Without any grace marks**.
- A minimum of **50% aggregate marks** in the three subjects is required (with **45%** for candidates belonging to **reserved categories**).

- The candidate must have passed **English** with a minimum of **30% marks** in the 10+2 examination.
- The candidate must have completed **17 years of age** on or before **31st December** of the year of admission.
- The qualifying examination must be conducted by a Board **recognized by the Central or respective State Government**.

## Bachelor of Pharmacy (Lateral Entry)

- If it further tallies then marks obtained in Biology and / or Mathematics, then Chemistry, then Physics, then English of qualifying examination shall be considered at the time of counselling.

- For Govt. Institutions:

## RESERVATION POLICY

### Reserved Seat Allocation:

- Seats are reserved for SC, ST, OBC, EWS, and PwD candidates as per the reservation policies of the relevant Central, State, or Union Territory government.
- Academic Eligibility for SC/ST/OBC Candidates:
  - Secured a minimum of 40% aggregate marks in Physics, Chemistry, and Biology.
  - Individually passed in English.

### Reservation for Candidates with Disabilities:

- 5% of seats are reserved for candidates with loco-motor disabilities of 40% to 50% affecting the lower limbs.
- Such candidates must fulfill the same academic eligibility criteria as those prescribed for General category candidates.
- A relaxation of 5 years in the upper age limit is granted to eligible candidates under this category.

# TERMS AND CONDITIONS

1. Students securing more than 95% marks in the 10+2 examination are eligible for a concession in admission fees, subject to verification and approval by the Admission Committee.
2. The booking amount does not ensure admission and is non-refundable under any circumstances.
3. Education loans will be facilitated upon request by the bank, and necessary documents will be provided accordingly by the institute.
4. University Registration Fees are mandatory and will be charged separately from the semester fees.
5. Fees once paid will not be refunded, irrespective of the reason for withdrawal or discontinuation.
6. In the event of a student withdrawing from the course after admission, he/she shall be liable to pay the full course fee for four years, regardless of the duration of attendance.

## DISCONTINUATION OF STUDIES

- Students intending to withdraw from the course must ensure that all dues, including tuition fees, are cleared in full. Only then shall a Transfer Certificate be issued.

- To provide a platform for students to voice their concerns regarding both academic and non-academic matters.
- To solicit student suggestions for improvement.
- To take appropriate actions to address grievances and implement necessary improvements.

Students are encouraged to utilize the suggestion boxes placed in various locations across the RIPSr campus to share their constructive feedback and grievances. These suggestion boxes will be available in every building, with grievance records kept in accessible areas such as the Library and Hostels, allowing students and staff to express their concerns. Complaints submitted via suggestion boxes, as well as oral grievances, will also be addressed. All complaints will be reviewed by the management and the grievance redressal cell, with oversight from the Chief Managing Director and Principal on a daily basis. The college assures students that all complaints will be treated with the utmost confidentiality. Additionally, a specialized mechanism will be in place to address issues specifically related to women and their grievances.

### Complaint Management Process:

The grievance management process at RIPSr operates at three levels:

- **Departmental Level:** Grievances will be handled by the relevant Class Coordinators, Mentors, and Department Heads.
- **Facilitator Level:** Student and staff coordinators from the grievance redressal cell will act as facilitators to communicate and resolve grievances at the departmental level.
- **Central Committee Level:** Any grievances that remain unresolved at the departmental level will be escalated to the Central Grievance Redressal Committee for further action.

# INTERNAL COMPLAINTS COMMITTEE (ICC) POLICY

In compliance with the UGC (Prevention, Prohibition, and Redressal of Sexual Harassment of Women Employees and Students in Higher Education Institutions) Regulations, 2015, and the Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act, 2013, the Rahman Institute of Pharmaceutical Sciences and Research (RIPSR) has established an Internal Complaints Committee (ICC) to address complaints related to sexual harassment within the institution.

## Complaint Handling Process:

- Upon receiving a complaint, the ICC will initiate a preliminary inquiry to investigate the allegations. This inquiry will involve collecting relevant evidence and obtaining statements from witnesses, including the complainant. The ICC will then compile a report detailing its findings and submit it to the Director, along with all necessary documentation.
- In cases where sexual harassment is committed by a third party or outsider, the ICC will take all necessary steps to support the affected individual and implement preventive measures. The ICC will follow the procedures outlined in the UGC Regulations, 2015, and the Sexual Harassment Act to ensure that all inquiries are conducted in a timely and efficient manner.
- If the ICC finds that a complaint is false, malicious, or made with knowledge of its untruthfulness or misleading nature, the complainant may be subject to disciplinary action as per the relevant provisions of the UGC Regulations, 2015.
- If the allegations do not meet the criteria for sexual harassment, the ICC may refer the matter to the Grievance Redressal Cell.
- All female employees—faculty, students, or staff—at RIPSR are encouraged to approach the ICC for assistance.

## Definition of Sexual Harassment:

Sexual harassment at RIPSR includes any unwelcome behaviour of a sexual nature, whether direct or indirect, such as:

- Physical contact and advances
- Demands or requests for sexual favours
- Sexually suggestive remarks
- Displaying pornography
- Any other unwelcome physical, verbal, or non-verbal conduct of a sexual nature

**Confidentiality:** All complaints will be treated with strict confidentiality.

### **Inquiry Process:**

The inquiry shall be completed within thirty days from the date of the complaint. Upon completion of the inquiry, the ICC will provide a report of its findings to the Director within ten days, and the report will be made available to the concerned parties.

If the allegations against the respondent are substantiated, appropriate punitive actions will be taken.

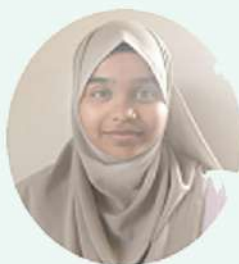

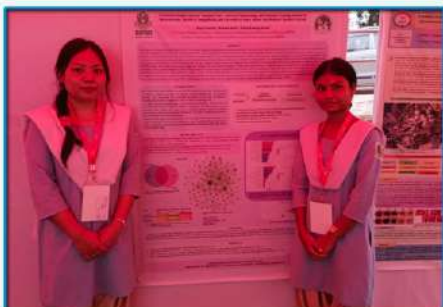
