MOULVIE ABDUL HEI

The man who knew the value of knowledge.

Born in 1932 in Keirao Makting, a small village now under Imphal East District of Manipur India, Moulvie Abdul Hei Saheb was destined to live a life of simplicity and righteousness. Being born to poor and illiterate parents meant that Moulvie Saheb had to shape his own destiny without much guidance.

At a very young age, he showed a strong yearning for knowledge and was driven by an inner urge for knowing the truth and sharing it with the people around him. This yearning took him to a madrasa in Uttar Pradesh for Islamic theological studies. Breaking from the tradition, he obtained formal education even while studying Islamic theology. During his stay, he was an ardent follower of Moulana Ahmed Ali in freedom struggle. He completed Pravodha and Rashtrabhasha Ratna from Bombay Hindi Vidyapeeth in 1965.

After a stint as an Imam of a village mosque around a tea garden near Golaghat in Assam, he shifted back to Manipur in 1959 to be with his ageing father. While in Assam, he married Kheirun Nisha, the daughter of the doctor at the hospital of the tea garden. Impressed by his suave and honest personality, many 'influential people' came to help him get a government job as a school teacher. He joined as an Assistant Teacher at Irilbung M.E. School in 1960. That was where he made a mark as a role model not only for his students but also for his friends and the public of the area. His commitment and the light way of teaching endeared him to one and all. The title of Oja Moulvie (Moulvie, the teacher) became an endearing identity. Even today, the title evokes an emotive reconnect.

After years of dedicated service as a teacher, he superannuated as the Head Master of Urup Keirao LP Madrasa in 1988.

Apart from being an exemplary teacher, Moulvie Saheb lived a very inspiring life. His simplicity, his patience, his sense of humour, his spiritual depth, his knowledge of the scriptures and Islamic law and his broad-mindedness make him a character worthy of folklore. People who spent time with him often recall how calm he remained in every situation displaying his highest level of faith in the Divine will. Never provoked or angered by any situation or person, he embraced everyone with love and guidance.

After every prayer, at every moment of contemplation, he used to recite 'Rabbi zidni ilma', the dua that connects one with knowledge and the source of all knowledge. Without a doubt, he was a man who knew the value of knowledge.

Having lived a fulfilling and inspiring life, Moulvie Saheb left us for the other world on 10th March 2000. What could have been a more befitting tomb in his memory than a trust that will run institutes of academic excellence? And that is the sole purpose of Moulvie Abdul Hei Memorial Trust.

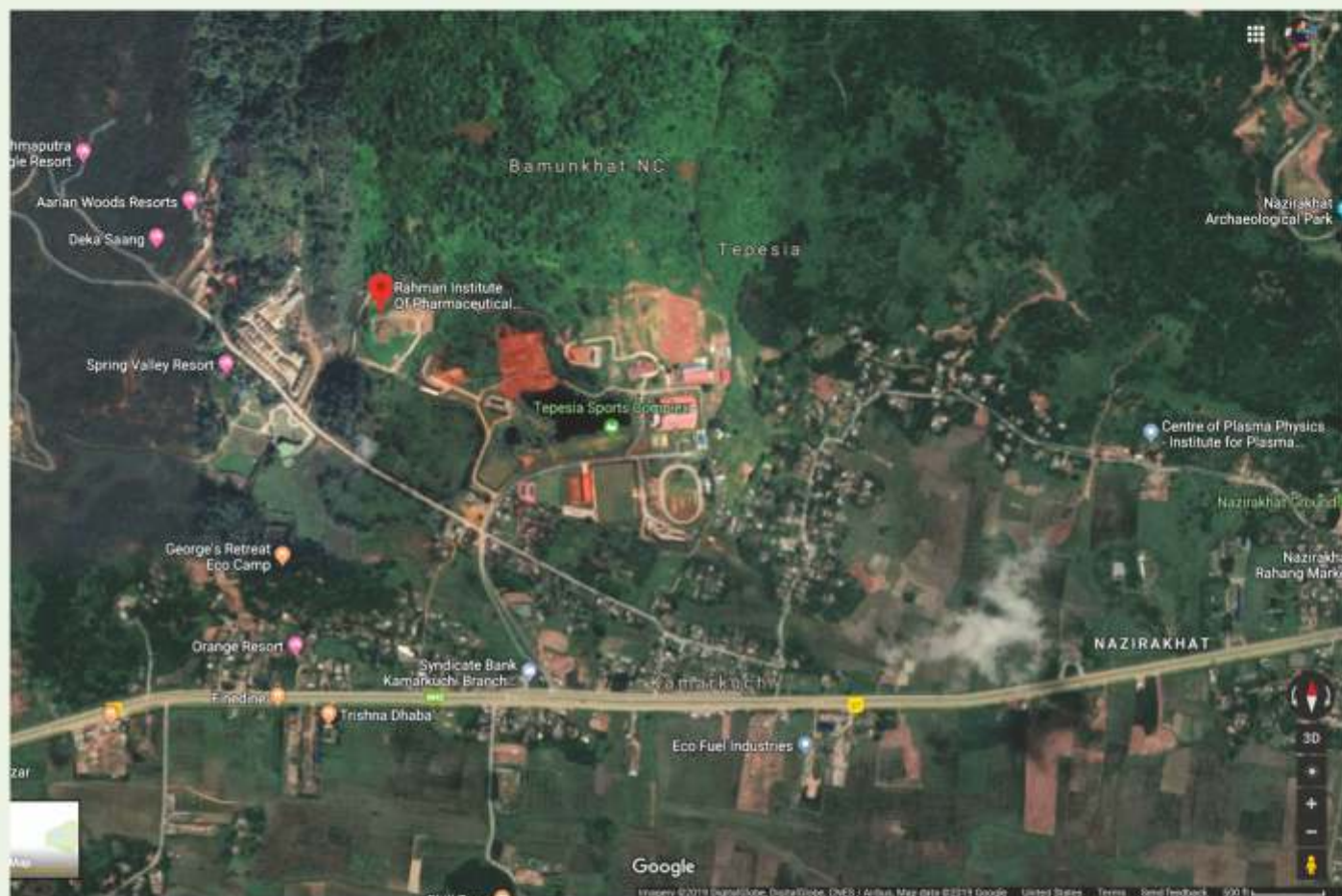

CLASS ROOMS

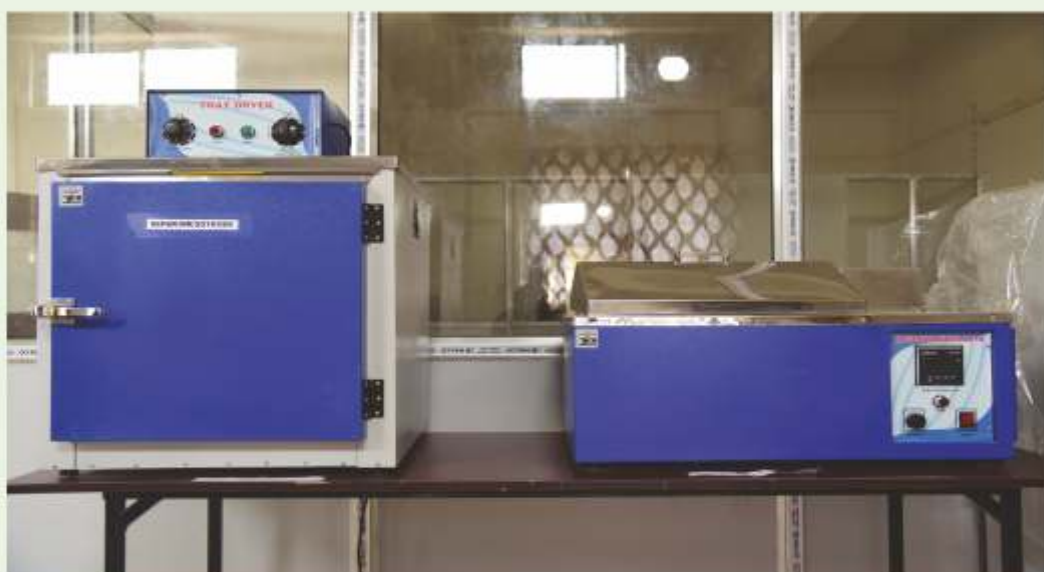
CENTRAL INSTRUMENTATION FACILITY AND MACHINE ROOM

The Central Instrumentation of Facility RIPSr has adequate instruments for conducting a practical session in the course curriculum. Instruments like UV-VIS Spectrophotometer, Flame Photometer, Tablet Disintegration Apparatus, Tablet Dissolution Apparatus, Colorimeter, Fluorimeter, Polarimeter and Refractometer help the student to gather the basic and applied knowledge in Pharmacy.

For performing different experiments associated with the formulation and development of different types of drugs, the institute has established a Machine Room.

The Machine room simulates an environment similar to a large scale Pharmaceutical Industry, for the exposure of the students to different levels of formulation, development and packaging of drugs.

The Machine room is equipped with Ampoule sealing machines, Tablet Punching Machine, Tablet Coating Machine, Hardness tester, Friability Tester, Capsule Filling Machine, and Ointment Filling Machine.



LEARNING AIDS

LIBRARY AND READING ROOM

The institute has a well equipped library and reading room with more than 1026 references and recommended textbooks for B.Pharm and D. Pharm courses. The library has 13 National and International journals subscription both print and in an online format to provide constant learning support and reference for its students and faculties. Reprography facility is also available in the library.



COMPUTER LABORATORY

The institute has established a computer laboratory with a high-speed internet connection of 32 Mbps speed. The lab is equipped with 20 computers in the ratio of 1:8, with latest configuration and legal software along with 5 high-quality colour printers and scanners. The Campus is WIFI enabled with adequate hotspots areas available around the campus.

Moreover, all the computers have a UPS power backup, supported by generators in urgent situations.



COMPUTER CENTRE - The institute has a very well-equipped computer centre with 20 multimedia computers with a high-speed internet connection of 32 Mbps speed. Computer Centre enables students to refer to the online resources for curricular and co-curricular needs. The institute also offers access to DELNET, which is an International Digital Library, which enables students to access International Journals. All the computers in the computer centre are well equipped with printers and reprographic facilities. Computer centre has a UPS power backup, supported by generators in urgent situations.

LANGUAGE LABORATORY - Language Lab has been setup to help students improve their language and communication skills which will aim at building their confidence for interviews and competitive exams. The lab has computers with language software and audio exercises to help the students to learn grammar and vocabulary with proper pronunciation.

TUTORIAL ROOMS - The institute also provides separate tutorial rooms for Diploma and Bachelor in Pharmacy courses, where teaching faculties can hold meetings, discussion and demonstration to students and departmental faculties.

HERBAL GARDEN - The institute has a herbal garden with a variety of medicinal and aromatic plants.

MUSEUM - The museum at RIPSr exhibits the milestones in the development of pharmacy as a profession. It depicts the evolution of pharmaceutical science.

SEMINAR HALL - The college has well-furnished seminar hall, which is equipped with state-of-the-art audio-visual equipment and public address systems with Cordless Microphones. A regular venue to hold seminars and manage placement activities of the institute. This hall accommodates around 150 students to conduct student induction programmes, pre-placement talks, group discussion, personal interviews and seminars.

AUDITORIUM - The institute has a 350 seater auditorium with a stage and a green room. The auditorium is well equipped with a projector screen and a PA system.

- Completed the age of 17 years on or before 31st December of the year of admission to the course.
- Must have obtained at least 45% marks (40% in case of candidates belonging to reserved category) in the above three subjects taken together.
- Must have passed English in the '10+2' examination with at least 30% marks.
- The Board of the said Qualifying Examination must be recognized by the Central Government or State Government concerned.

For B.PHARM

- Candidate must have passed '10+2' examination with Physics and Chemistry along with any one of Mathematics/ Biology/ Computer Science as compulsory subjects with individual pass marks (in both theory and practical wherever applicable) in all the three subjects as stated above in regular class mode.

For B.PHARM (Lateral)

On receipt of a complaint, ICC shall conduct a preliminary enquiry to ascertain the truth behind the allegations by collecting necessary evidence to prove the claims put forward and shall also record statements of witnesses including the complainant. The ICC shall then submit the report of the preliminary enquiry to the Director along with the evidence and documents collected for further proceedings.

Where sexual harassment occurs as a result of an act or omission by a third party or outsider, ICC shall take all the necessary steps and reasonable action to assist the affected person in terms of support and preventive action.

ICC shall comply with the procedure prescribed in the aforementioned UGC Regulations 2015 and the Sexual Harassment Act for inquiring into the complaint in a time-bound manner. If ICC concludes that the allegations made were false, malicious or the complaint was made knowing it to be untrue or forged or misleading information has been provided during the inquiry, the complainant shall be liable to be punished as per the relevant provision of the aforementioned UGC Regulations 2015. In case the allegations are not in the nature of Sexual Harassment, ICC may refer such complaints to the Grievance Redressal Cell. Any female employee (faculty, student or staff) of RIPSIR can approach ICC for help.

Definition of Sexual Harassment:

"Sexual harassment includes any unwelcome sexually inclined behaviour, whether directly or indirectly, such as:

Physical contact and advances	Demand or request for sexual favours
Sexually coloured remarks	Showing any pornography, or
Any other unwelcome physical , verbal or non-verbal conduct of sexual nature	

Complaints will be kept **CONFIDENTIAL**.

Inquiry process:

- The inquiry shall be completed within a period of thirty days from the date of the complaint.
- On completion of the inquiry, the ICC shall provide a report of its findings to the Director within a period of ten days from the date of completion of the inquiry and such report be made available to the concerned parties.
- If the allegations against the respondent have been proved, punitive actions will be taken against the respondent.
